- **5** Pamilla A.² Burke (573) was born on 15 Jul 1841 at Missouri.<sup>424</sup> She was enumerated with Elizabeth Ann Bland (534) on the census of 13 Aug 1850 at Weston, Platte County, Missouri, listed as Pamilla Burk an 8 year old female born MO.<sup>425,426,427</sup> She may be the parent of Davis Burke. 1860 census shows a 1 year old child in household of Elizabeth Ann Burke listed below John M. Burke.<sup>428</sup> She was enumerated with Elizabeth Ann Bland (534) on the census of 29 Jun 1860 at Marshall Twp., Platte County, Missouri, listed as Perilla Burk a 19 year old female born MO.<sup>429</sup>
  - **51** Davis³ Burke (643)⁴³⁰ was born circa 1859 at Missouri.⁴³¹ He may be the son of Pamilla Burke. 1860 census shows a 1 year old Davis Burke in household of Elizabeth Ann Burke listed last.⁴³² He was enumerated with Elizabeth Ann Bland (534) on the census of 29 Jun

1860 at Marshall Twp., Platte County, Missouri, listed as Davis Burk a 1 year old male born MO.

6 John Martin<sup>2</sup> Burke (574) was born on 30 Apr 1844 at Missouri.<sup>433</sup> He was enumerated with Elizabeth Ann Bland (534) on the census of 13 Aug 1850 at Weston, Platte County, Missouri, listed as John Burk a 6 year old male born MO.434,435 He is head of household on the census of 29 Jun 1860 at Marshall Twp., Westmoreland County, Missouri, as John Burke, a 16 year old male farmer bron MO.436 He was enumerated with Elizabeth Ann Bland (534) on the census of 29 Jun 1860 at Marshall Township, Platte County, Missouri, listed as John Burke a 16 year old male farmer born Missouri.<sup>437</sup> He and Milton E. Burke (571) were defendants in case brought by Guilford Hornbuckle and Sara E. Hornbuckle, his wife and Hiram Curry and Angelina Curry, his wife, for partition of the east half of the southwest guarter of section 34 T54 R36 on 5 May 1876 at Weston, Platte County, Missouri. 438 He and Milton E. Burke (571) were petitioned by Gilford Hornbuckel and Sarah Hornbuckel his wife and Hiram Curry and Angelina Curry his wife for partition of land being the E 1/2 Section 34 T54 R36 in Nov 1876 at Platte County, Missouri. 439 He and Milton E. Burke (571) were defendants in a court case and asssessed \$679.92 in a finding for plaintiffs Guilford Hornbuckle and Sarah, his wife and Hiram Currey and Angelina Currey, his wife on 5 Apr 1877 at Platte County, Missouri. 440 He and Milton E. Burke (571) as defendants lost appeal of earlier decision favoring plaintiffs Guilford Hornbuckle and Sarah Hornbuckle, his wife and Hiram Curry and Angelina Curry, his wife on 10 Apr 1877 at Platte County, Missouri.441 He and Milton E. Burke (571) were granted permission to appeal case filed by Guilford Hornbuckle and Sarah Hornbuckle, his wife and Hiram Curry and Angelina Curry, his wife, to the Missouri Supreme Court on 10 Apr 1877 at Platte County, Missouri.442 He purchased from Milton E. Burk of Platte County Missouri, land being the E 1/2 SW 1/4 S34 T54 R36 except all that part of said east half of said guarter so in lying east of Bear Creek on the SE corner of said east half also the north half of the west half of SE 1/4 of 234T54R36 also a part of the NW 1/4 section 34 T54 R36 beginning at the SE corner of the NE 1/4 of said section and running north on said guarter section line two and one half rods thence west 6 rods thence south 2 1/2 rods thence east 6 rods to place of beginning on 29 Sep 1877 at Platte County, Missouri.443 He married Mary M. Hooper (6776) on 10 Sep 1884 at Clay County, Missouri, 444,445
